Investment Objective

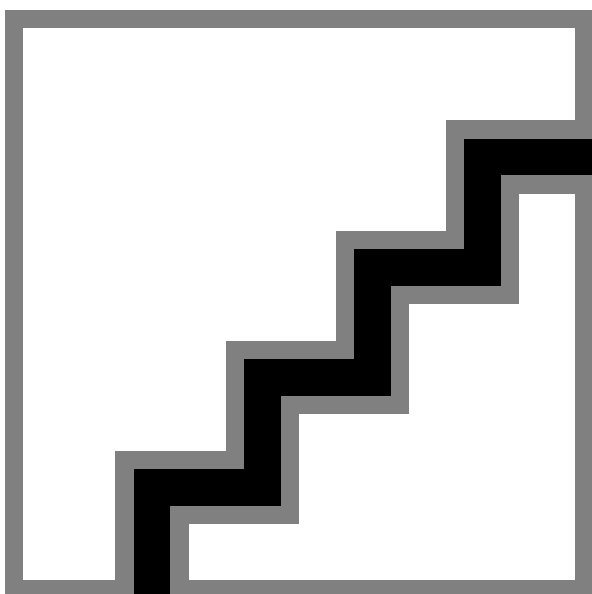

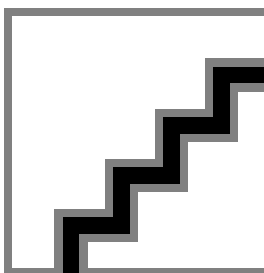
