#### Investment Objective

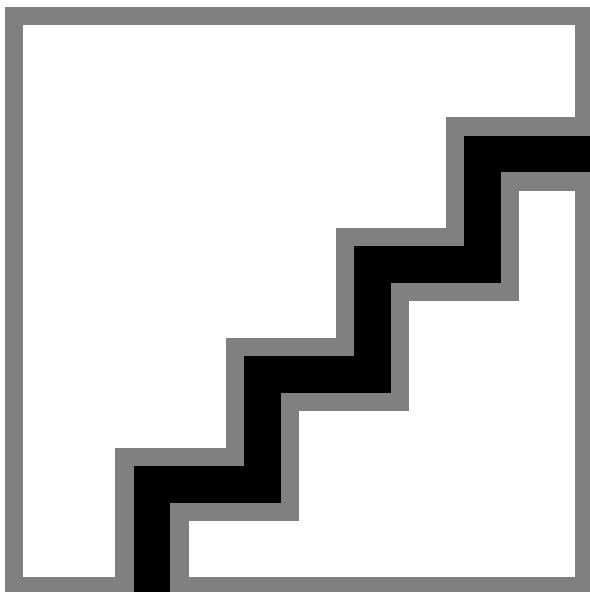

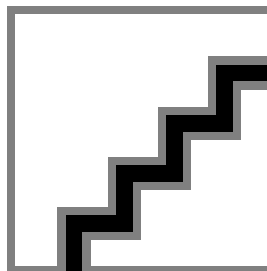

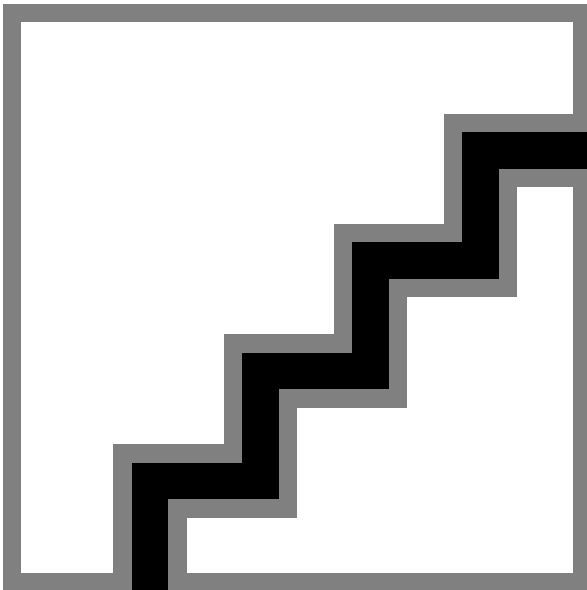
