Investment Objective

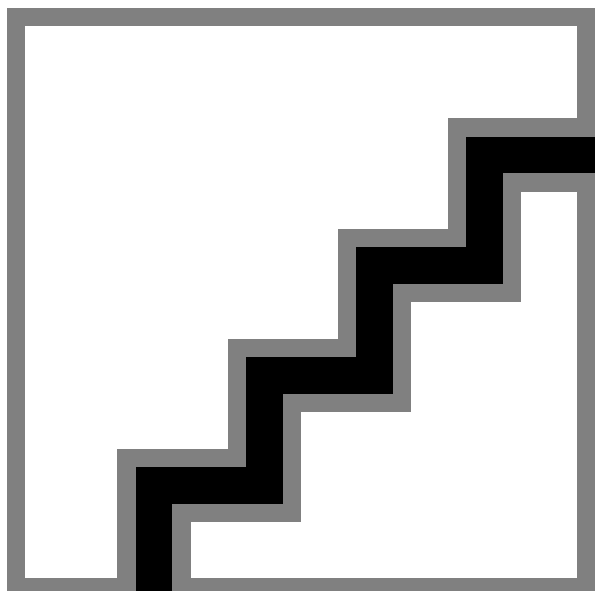

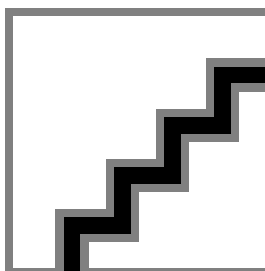

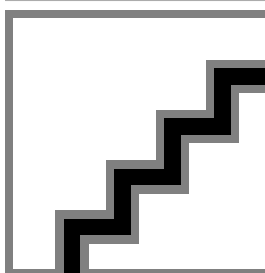

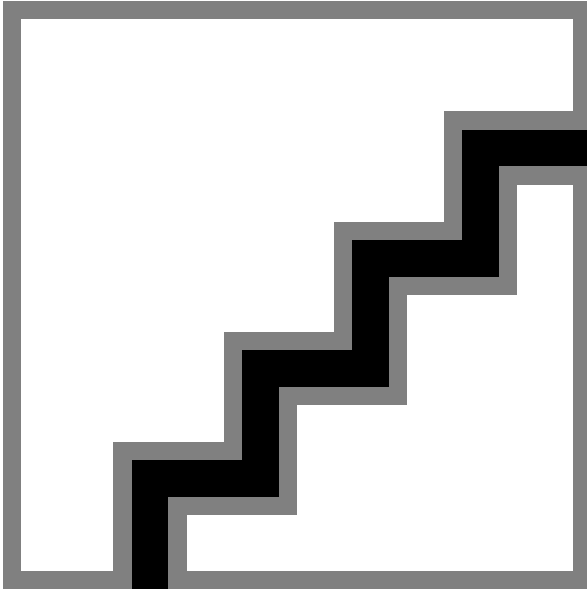
