Investment Objective

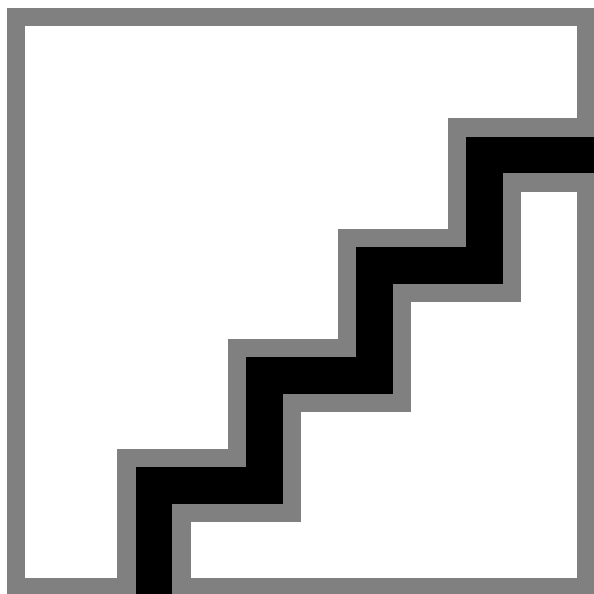

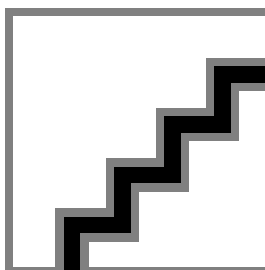

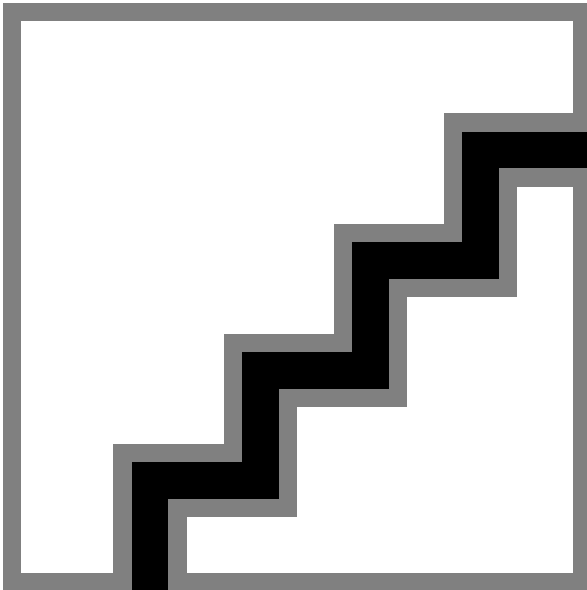
