#### Investment Objective

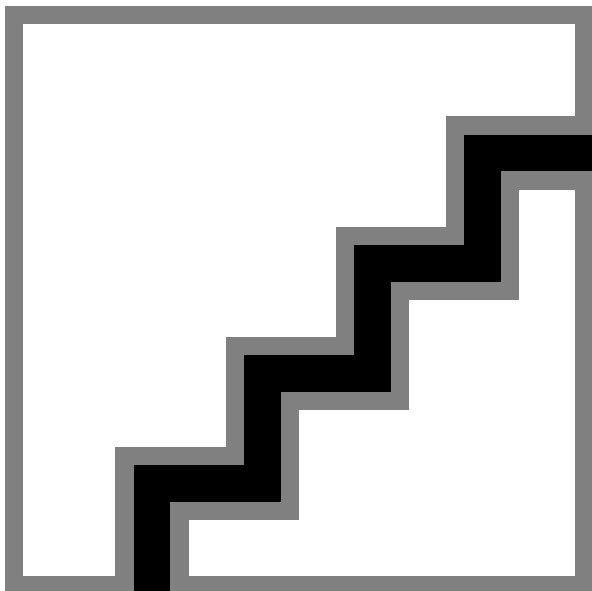

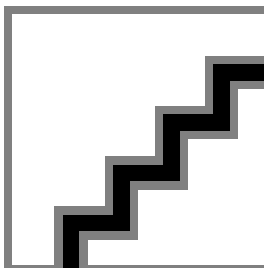

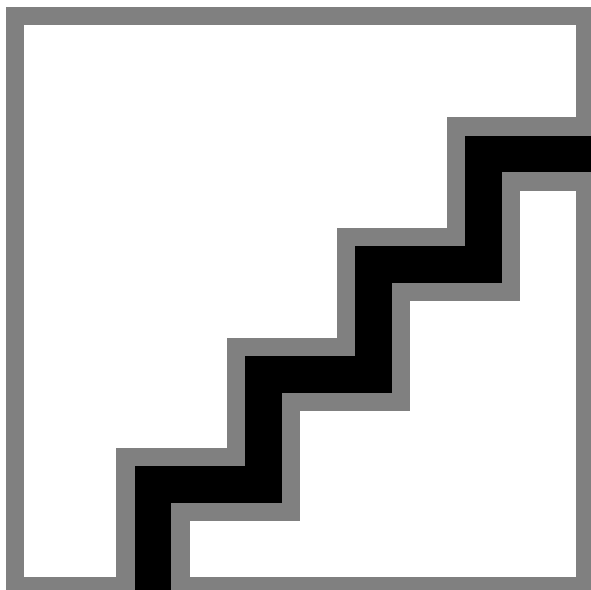
