#### Investment Objective

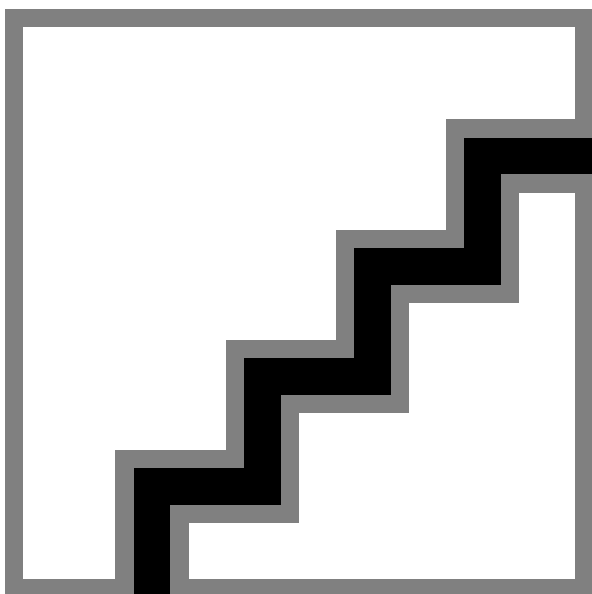

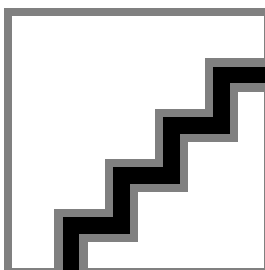

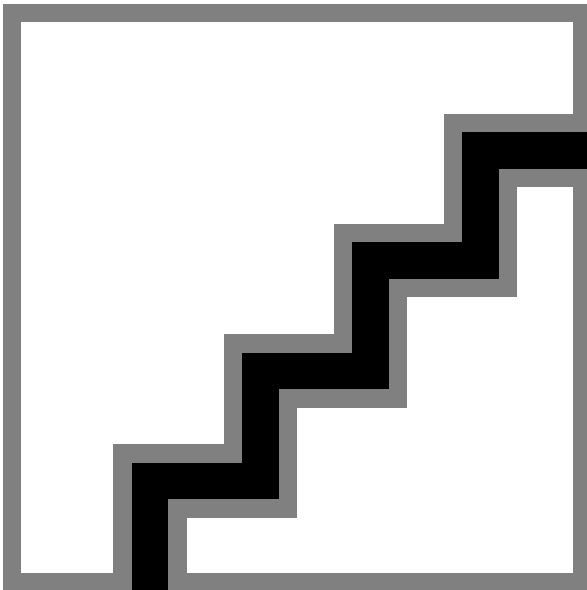
