#### Investment Objective

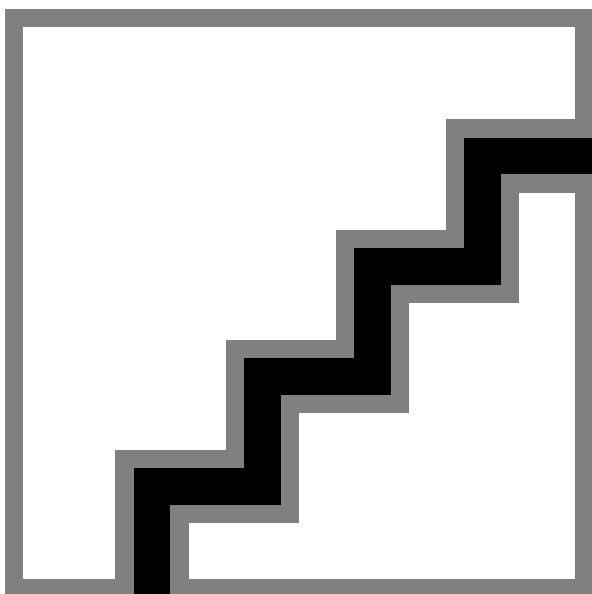

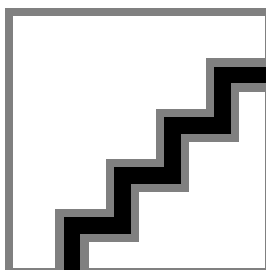

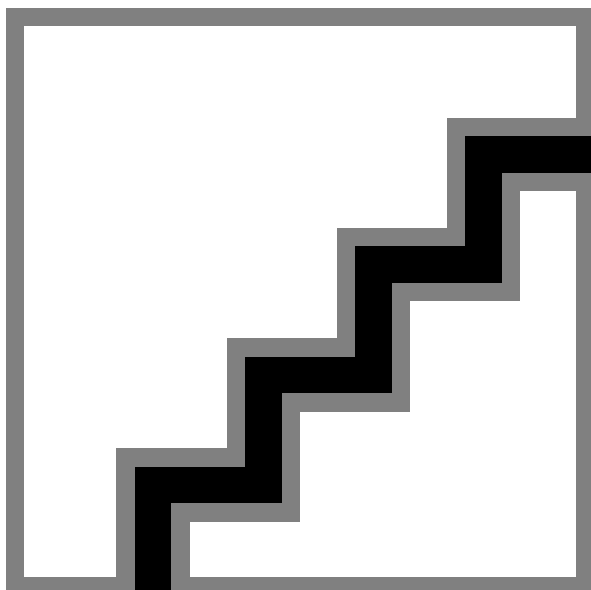
