Investment Objective

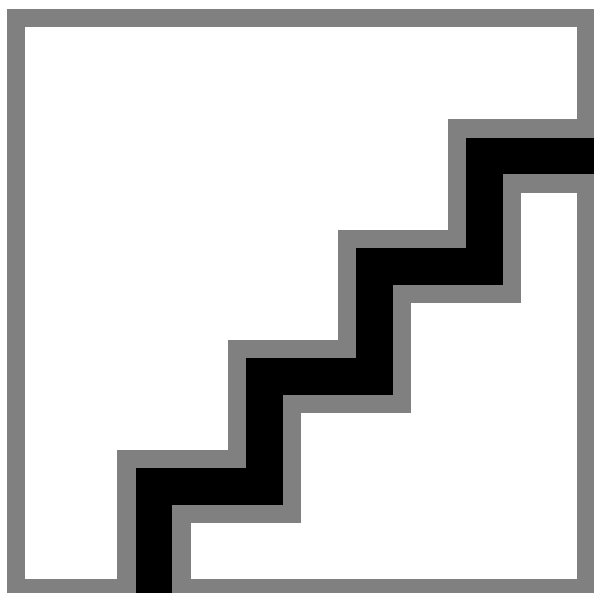

For the equity portion of the Sub-Fund, the Sub-Fund seeks to invest in China A-shares and B-shares listed on stock exchanges in mainland China, H-shares listed on The Hong Kong Stock Exchange ("SEHK") and other mainland China-related shares or securities listed on the above exchanges as well as on other exchanges outside mainland China, Hong Kong and Macau ("other mainland China-related listed securities").

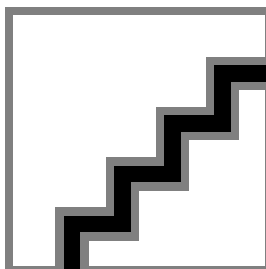

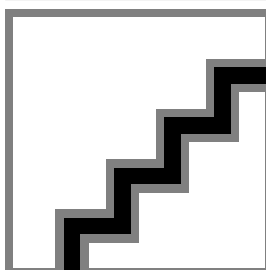

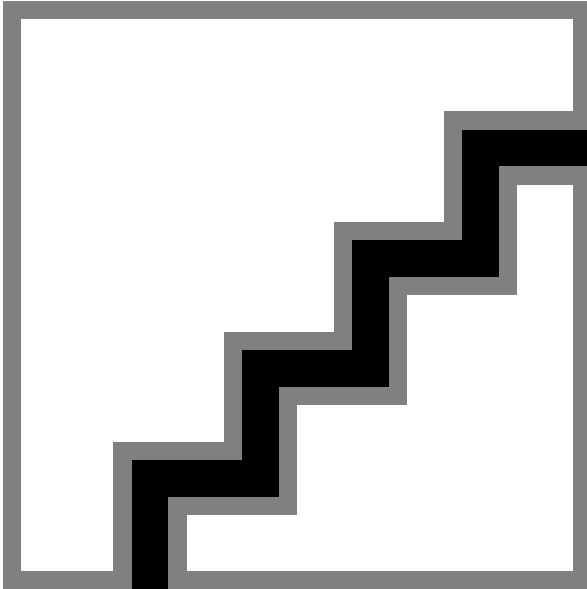
