Investment Objective

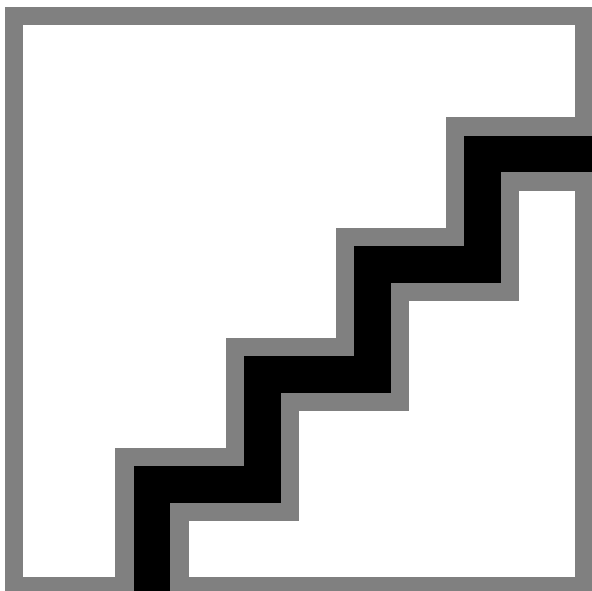

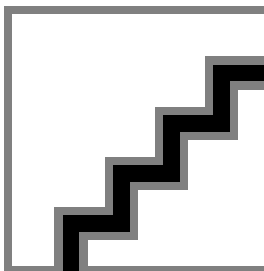
