Investment Objective

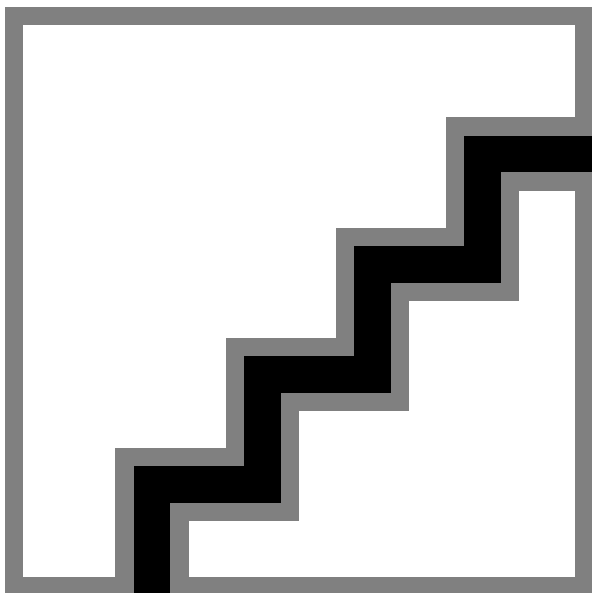

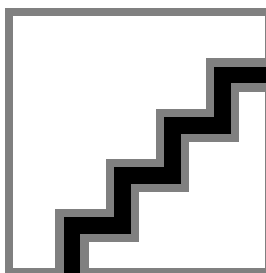

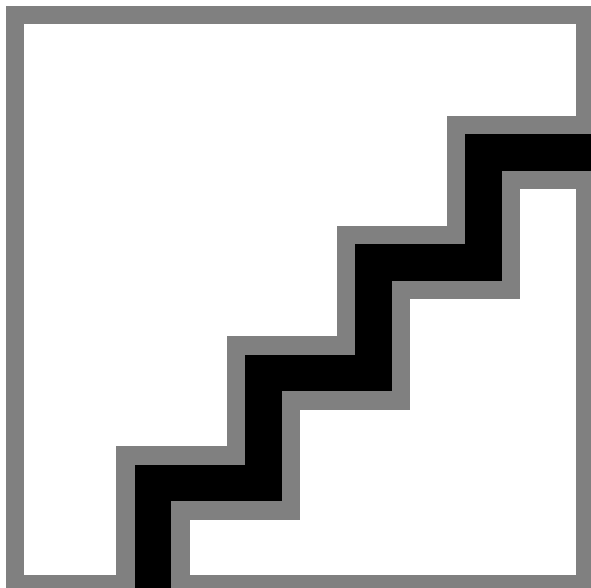
