Investment Objective

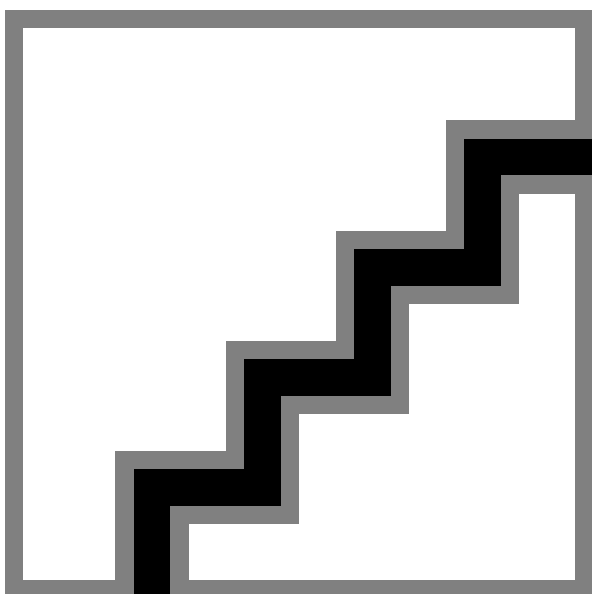

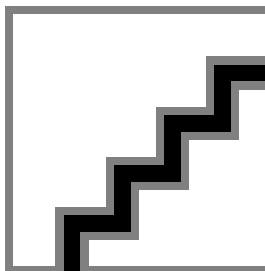
