#### Investment Objective

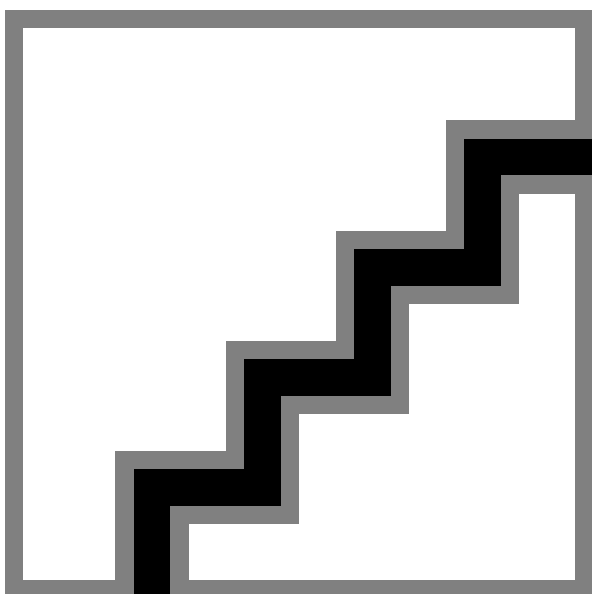

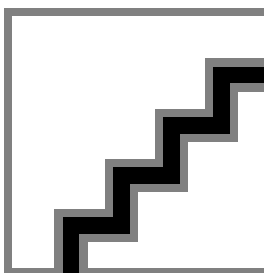
