Investment Objective

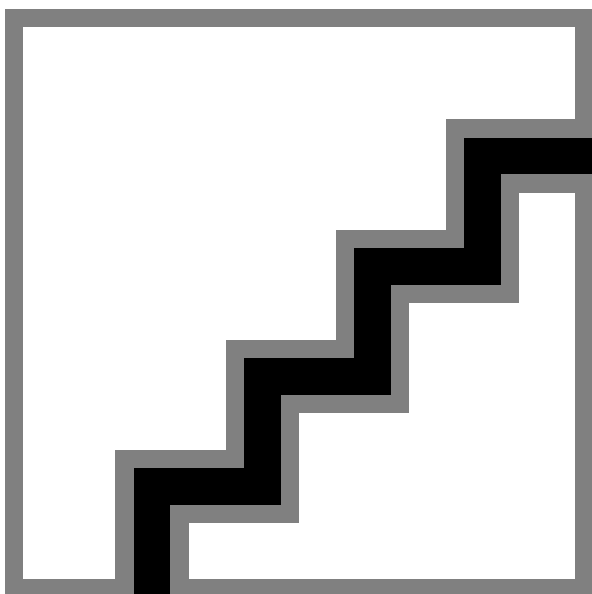
