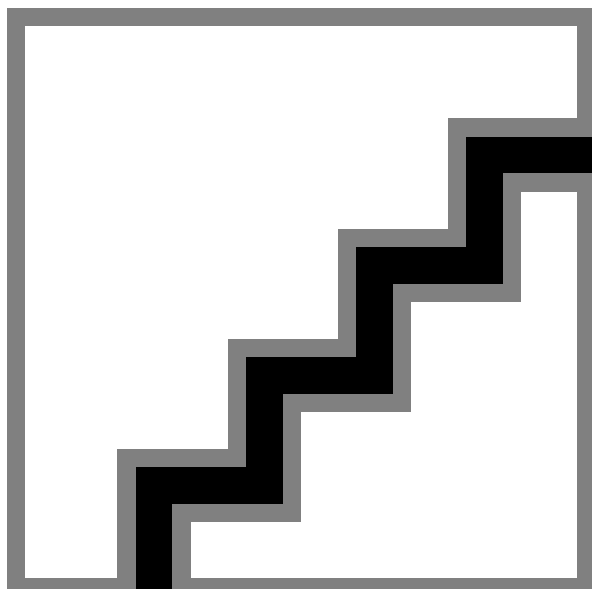

(as of 31-03-2025)

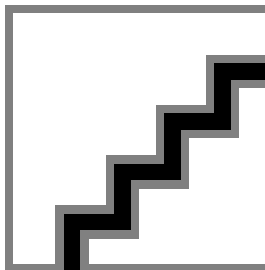

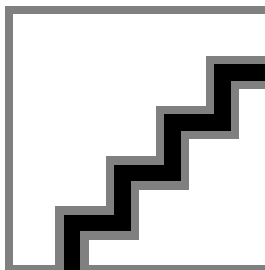

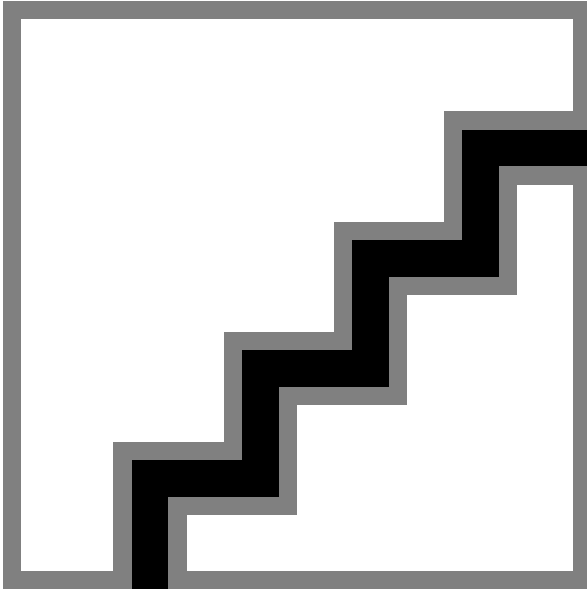
