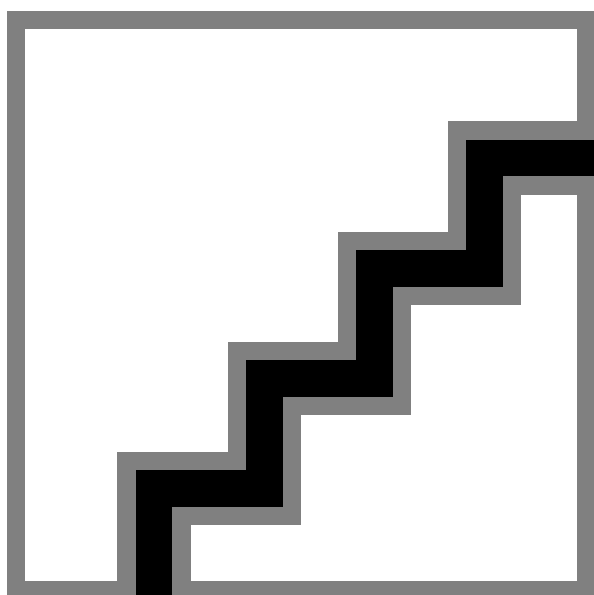

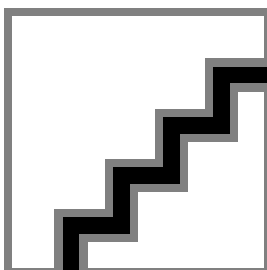

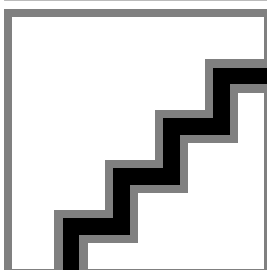

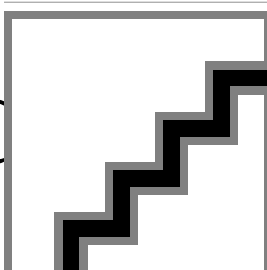
Equity holdings geographical allocation

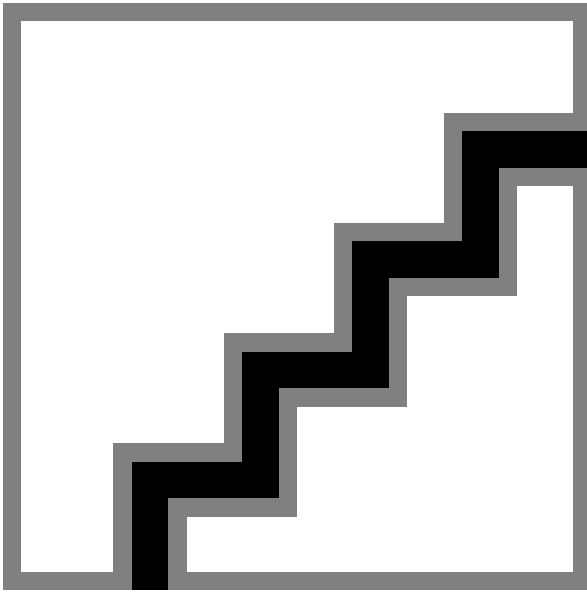
