Investment Objective

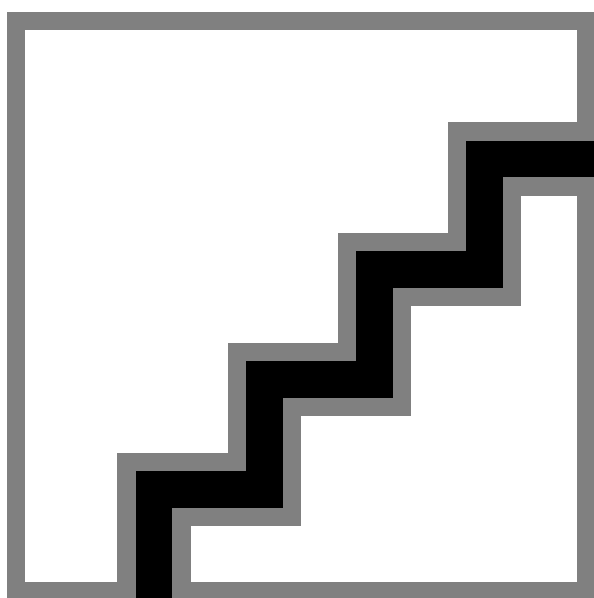

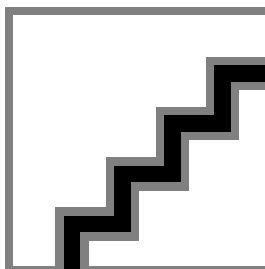

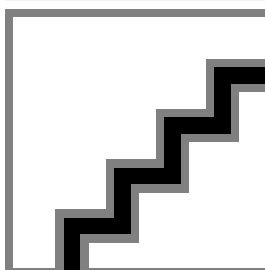

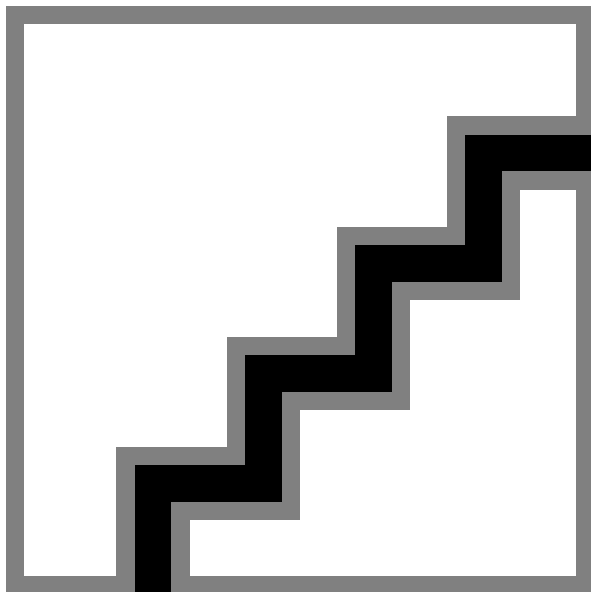
