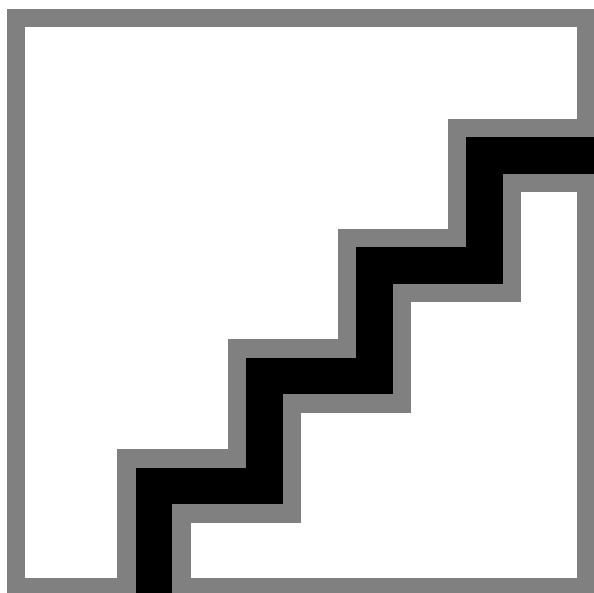

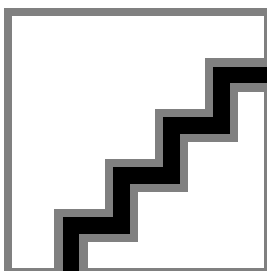

##### Asset allocation

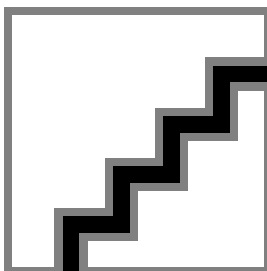

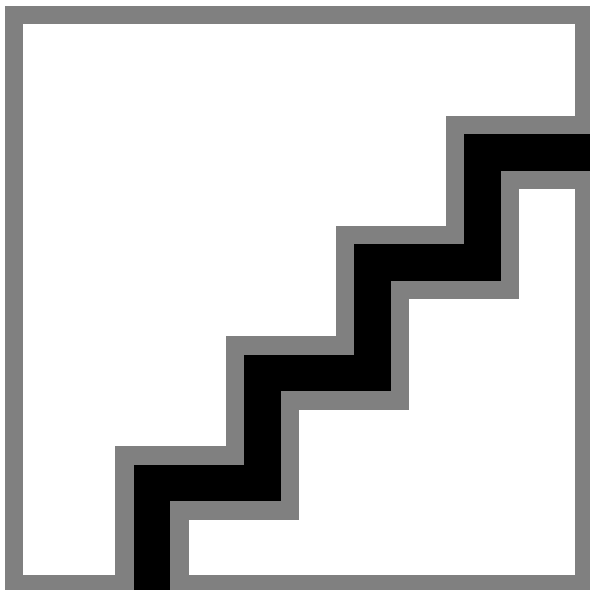
