Investment Objective

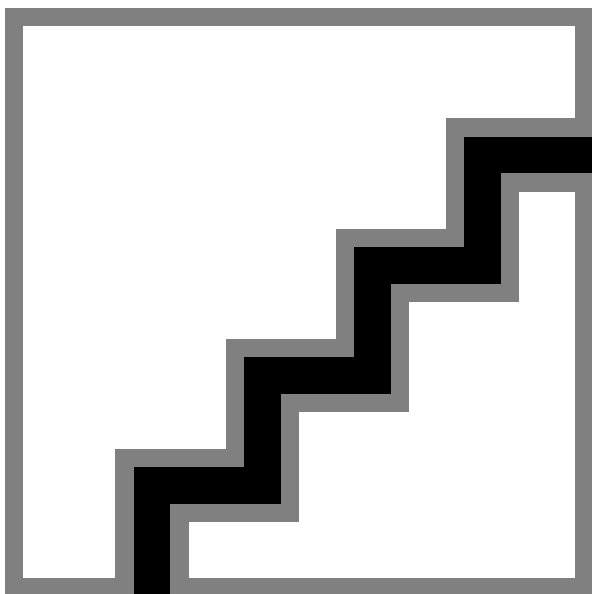

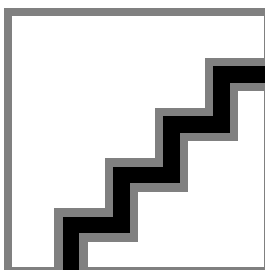

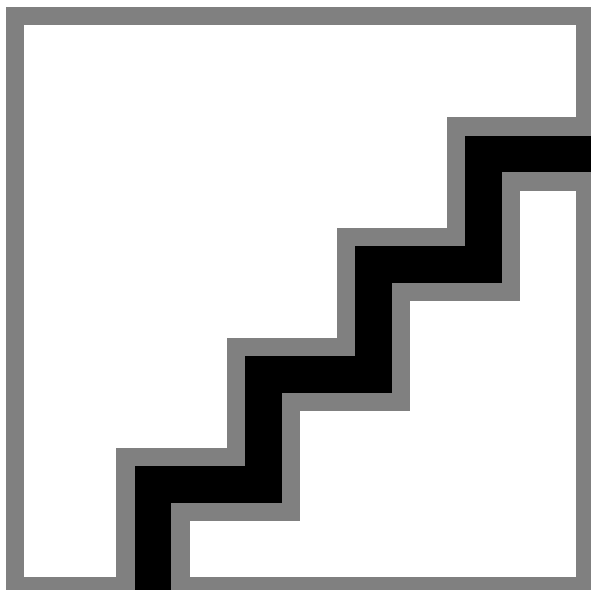
