Investment Objective

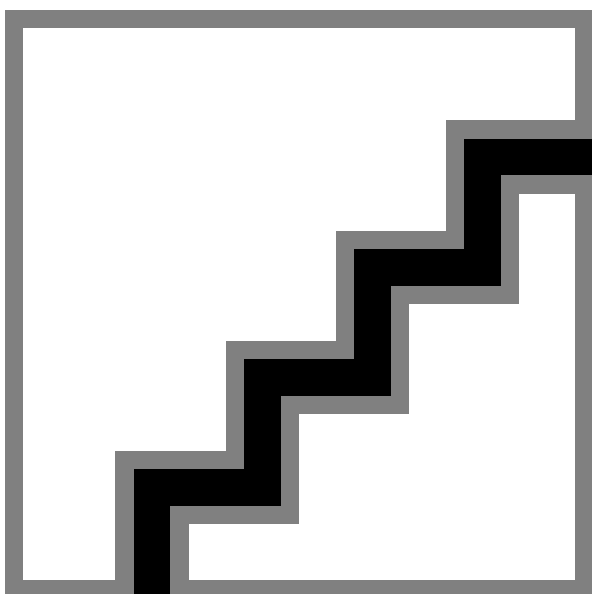

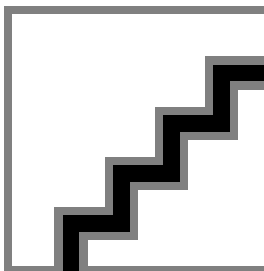

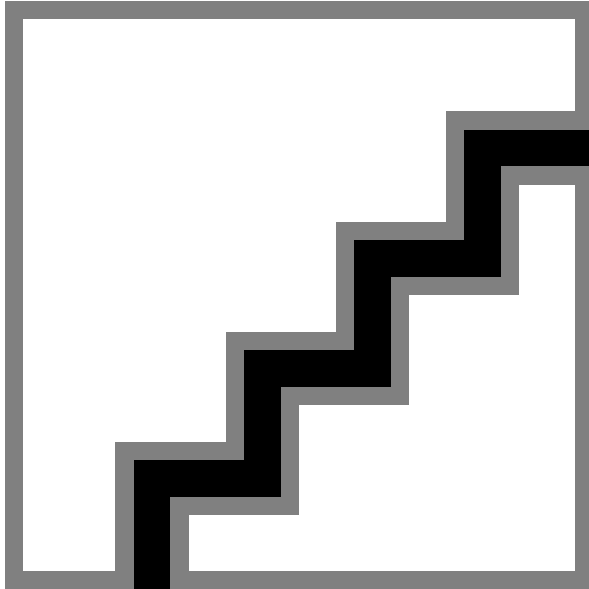
